Programme Objectives

The general objective of the Programme is to increase cultural dialogue and to foster European identity through understanding of cultural diversity.

Also, the Programme aims to:

- broaden the possibilities of accomplishing various artistic and cultural activities;
- strengthen participation in culture for the public;
- deeper understanding of cultural diversity and strengthen intercultural dialogue, including with cultures of minorities;
- Strengthen bilateral relations between Romanian cultural operators and those from the Donor States in the field of arts and culture, with emphasis on cultural diversity.









Programme Outcomes

Awareness of cultural diversity raised and intercultural dialogue strengthened:

- Increased mobility for artists and their works at international level;
- Education through art and culture reaching a broader audience;
- Projects concerning music and stage arts;
- Projects concerning fine and visual arts;

Cultural history documented:

- Cultural history of minorities enhanced and promoted
- Events/productions involving minorities (fairs, performances, festivals, productions, etc.).









Programme Budget

Total: 8,022,059 euro

- ➤ 6.818.750 euro, SEE contribution;
- ➤ 1.203.309 euro, Romania contribution.

Grant Allocation

- Large projects (between 50.000 200.000 euro/project) total budget 6.327.957 euro for Measure 1 and 2;
- Small projects (between 5.000 15.000 euro/project) total budget 623.566 euro for Measure 1 and 2;
- ➤ <u>Bilateral relations</u> **1500** euro/partnership action; total budget: **120. 320 euro**.

At least 10% of the total eligible costs of the Programme are destined to cultural projects seeking to improve the situation of the Roma population.









PROJECT GRANT RATE

- •non-governmental organisations grants cover up to 90% of the project eligible costs;
- •natural persons grants cover up to 95% of the project eligible costs;
- •public entities grants cover up to 100% of the project eligible costs .

Large projects - total budget

Outcome 1: Awareness of cultural diversity raised and intercultural dialogue strengthened – 3.701.522 EUR.

Outcome 2: Cultural history documented – 3.250.000 EUR.

Grant Amounts

- the minimum grant amount is EUR 50.000 per project
- the maximum grant amount is EUR 200.000 per project

Small projects Budget

Outcome 1: Awareness of cultural diversity raised and intercultural dialogue strengthened – 323.566 EUR.

Outcome 2: Cultural history documented – 300.000 EUR.

At least 100.000 EUR of the total budget of the present call is allocated to cultural projects seeking to improve the situation of the Roma population.

Grant amounts

- the minimum grant amount is EUR 5.000 per project;
- the maximum grant amount is EUR 15.000 per project.

Bilateral relations

Measure A – Partnership development / building - the search for partners prior to or during the preparation of a project application, the development of such partnerships and the preparation of a project application for a donor partnership project;

Budget allocation – 84.232 Euro

Measure B – Networking and exchange of experience - networking, exchange, sharing and transfer of knowledge, technology, experience and best practices between project promoters and entities in the Donor States.

Budget allocation – 36.100 Euro









Bilateral relations – call November 2013 Eligible activities

- ➤ Meeting or searching for a potential partner for a future project between the Romanian entity and a partner/ potential partner from a Donor State;
- Attending different conferences, study trips, visits, meetings organized by potential partners from Donor States aiming at identifying ways and partners for developping donor partnership projects.









Bilateral relations – call November 2013 Eligible applicants/partners

- Public bodies in the field of culture, legally established and based in the Donor states, organized and managed according to the applicable law;
- Nonguvernmental and nonprofit organizations, legally established and based in the Donor States, organized and managed according to the applicable law;
- Natural persons: creators, artists and experts from the field of culture, students.









Bilateral relations – call November 2013

Measure A – Budget allocation – 45.000 Euro

Partnership action allocation – 1500 euro/entity, reimbursement

Eligible expenses:

- international travel (round trip), economic class;
- > subsistence allowance expenses: accommodation, per diem under national legislation;
- ➤ local transportation in Romania and in Donor States according to provisions of the national legislation;
- > access to conferences, seminars and workshops;
- > travel insurance.
